







Jay Weiss discussed his new novel at JCC

MATTERS FOR SENIORS

There are numerous health benefits to quitting smoking for

DARVO and the cease-fire

As I write these lines, Hamas and Israel have false announcement in preparation to create a signed a cease-fire deal that may bring our hostages home. Pidyon sh'vuyim (the rescue of hostages) is an important Jewish value and we welcome the possibility of an end to the violence. Of course, by the time you read this the deal may have fallen through or may be holding. I

hope for the latter, but prepare for the former.

The conflict with Hamas and the early reactions to the ceasefire deal do not give a guarantee that the deal will hold. In an early communique, Hamas



situation in which they can blame Israel for the violation of the agreement. Israel, for once, met this upfront by clearly saying these prisoners will *not* be in the list of Palestinian prisoners to be released. Considering that in the Gilad Shalit exchange one of the prisoners released was Yahia Sinwar, Israel unwillingness to release these murderers is quite understandable – to us.

EXECUTIVE DIRECTOR

announced that specific longtime prisoners in Israeli jails were included in the exchange, such as Marwan Barghouti – an Arab leader from the West Bank serving several consecutive life sentences who was responsible for the organization of terrorist attacks during the first Intifada. Israel's announcement, by contrast, clearly states that neither Barghouti nor any of the other names announced by Hamas will be included in the exchange. So what is going on? It would not be the first time that Hamas makes

The Hamas announcement fits into a larger strategy that the Palestinian side has been using for many years, and that it parallels very closely with the concept of DARVO.

DARVO is an acronym for "Deny, Attack, Reverse Victim and Offender." The concept is most commonly used to describe a strategy used by abusers to escape responsibility, but research indicates it is a common and effective manipulation strategy as well. So how does this apply to the issue at hand?

Deny: For several decades, the Palestinian and Arab leadership, supported by the Soviets while there was a Soviet Union, denied Israel's right to exist, denied the role played by Palestinian leadership – especially Amin al Husseini – in the Nazi Genocide, denied the pressure exerted by Arabs for Britain to block Jewish immigration (a U.S. representative of Palestinian origin even went to the extreme of saying how "her people" welcomed the Jewish refugees fleeing the Nazis). They also denied there ever was a Jewish Temple and denied the connection of Jews to the land. I could go on, but I think *deny* applies here.

Attack: Not only have Arabs been attacking the Jewish state since the day it declared Independence, but they also blamed Israel for everything that went wrong for them. All their inefficiency and failure in setting up their own institutions and governance has been blamed on the "Zionist occupation." They also blamed Israel for "oppression" and current Palestinian Authority President Mahmoud Abbas went as far as blaming Jews for the Holocaust in his Ph.D. thesis. Israel is attacked for everything they do, for everything they don't do and for everything that looks convenient in the Palestinian political agenda.

Reverse victim and offender: Of course, since Israel is responsible for everything that goes See "DARVO" on page 9


















Jewish fighters in World War II

(Tenth article of history series)

The best knows story of Jewish fighters in World War II is the story of the Warsaw Ghetto rebellion that started on the eve of Passover in April 1943. While the rebellion was doomed to fail from its very inception, and the fighters knew it, it allowed many Jews to escape the ghetto through the sewers during the fighting. Their courage, along with the connection with Passover, made the story of the uprising a very important part of the Jewish narrative, becoming a symbol for generations to come and an important element that became a part of the Jewish military ethos.

It is a poorly known fact that, during World War II, the British Army included a Jewish Brigade. But how did it come to be created?

The leadership of the Jewish Agency for Palestine (yes, that was its name then), including Ben Gurion, determined early on that it was in the best interest of the Jews to support the Allies' efforts against Nazi Germany, even if that meant suspending the fight for an independent Jewish state. The Agency offered the British government to form a Jewish battalion to fight in Europe as part of the British army. London, however, was reluctant to form an exclusively Jewish Palestinian battalion. It tried, instead, to form a Palestinian battalion including both Jews and Arabs. When many Jews volunteered for the battalion while very few Arabs did, the British opted for recruiting Palestinian Jews into the regular army rather than as a distinct colonial battalion. This policy held for most of the war.

In 1944, however, London came under pressure to reconsider the formation of a Jewish battalion and, toward the end of 1944, the Jewish Brigade was officially formed. The Colonial office, however, feared that the Brigade could became the origin of a Jewish force strong enough and experienced enough to challenge the control over Palestine. They put Brigadier Ernest Benjamin (a British Jew) as commanding officer, and they integrated the Brigade into the 15th Army group. The Arabs of Palestine saw the formation of the Jewish Brigade as a British betrayal. London kept the Brigade stationed in North Africa away from military action until the end of 1944, when it transferred them to Italy, but they were not sent into action until the spring offensive of 1945. They were stationed in northern Italy near the Yugoslavian border.

Some of the Brigade's officers were in fact members of the Hagannah and they helped organize what came to be known as "the Brichah" ("The Escape"), an operation intended to bring Holocaust survivors from Europe into Palestine by breaking the British blockade. While the brigade was disbanded in 1946, some of its officers were instrumental in sustaining the transfer of Jews to Palestine afterwards: they also organized the famous "Exodus 1947" operation, which became an important element in the fight for the establishment of a Jewish state.

But the brigade also had a darker side. Some brigade members, incensed at what they saw as a lack of will on the part of the Allies to pursue and punish Nazi war criminals involved in the execution of the Holocaust, took justice into their own hands. Based on survivors' testimonies, they pursued, arrested and tried in kangaroo courts Nazi officers and soldiers. They functioned as judges, jury and executioners.

But there was also a brighter side to the brigade. Many soldiers wrote in their diaries of the reaction of Holocaust survivors when they saw the jeeps of the brigade with the Star of David on it: their eyes would light up at the idea of a Jewish army. Many of these survivors related years later how the sight of the brigade helped bring hope back into their lives.

There is also the story of the Jewish volunteers who jumped behind enemy lines to try to establish communications with the anti-Nazi resistance in several European countries. One of them was Hannah Szenes, who parachuted in Hungary and helped rescue Hungarian Jews bound for Auschwitz. She was eventually caught and executed by firing squad. There was also Enzo Sereni, an Italian Jew who parachuted into Italy and helped connect the Italian resistance with the Allied troops. He was eventually caught by the Nazis in November 1944 and sent to Dachau.

After the war, their fighting experience – especially of the members of the Jewish brigade – was an important asset to the Yishuv (Jewish community in British Palestine) because of their experience of functioning in a modern army. They were central to the development of tactics and logistics for the newborn IDF, and thus were instrumental in giving the Jewish army an advantage over the Arabs in spite of the great initial numerical disadvantage.

There were numerous other uprisings in concentration camps and mass escapes from death camps, as well as Jewish resistance groups all over occupied Europe. The best known of the resistance groups was that of the Bielski brothers in the marshes of Belarus. This group not only fought the Nazis, but sustained a population of over 1,000 Jews

hiding in the forest.

The history of Jews in World War II is a history of resistance and a struggle to preserve life. When the Israeli Knesset voted to establish an official day to commemorate the Shoah, it named it – appropriately–Yom HaShoah V'HaGvurah (The day of commemoration of the Holocaust and Heroism).







DARVO... • Continued from page 3 wrong, the Palestinian side did nothing wrong. The years of terrorist attacks and wars, as well as the diplomatic offensives at the U.N. and other forums, are not seen by Palestinians as offenses. They are presented (and for many Palestinians they are seen) as a reaction to the perceived offenses by Israel. This plays very well on social media with a audience that is generally poorly educated about the complexities of the conflict, an audience that is also ignorant of history. Under the assumption that the weaker side is always right, it follows that the stronger side is always wrong, so the stronger side cannot, in their mind, be the victim – only the offender.

Arafat's strategy was cruder and more direct. His approach is referred to in psychology as "accusation in a mirror," a common hate speech incitement technique, which consists of accusing the other of doing what the offender him/herself is doing. In past years, that Arafat strategy was sometimes referred to as "boomerang speech."

Both strategies were championed by the Nazis and the Soviets who trained the Arabs on state propaganda. Israel, on the other hand, is guilty of naivete. Convinced that facts are accepted by everybody, Israelis used over time concepts like "everybody is entitled to their own opinion, but not their own facts," missing the point on how opinions can become facts, especially in the era of social media.

The American Jewish community has not been better than the Israelis. It is time that we stand up together against the distortion of reality spearheaded by the Palestinians and their allies in the west. (Greta Thunberg comes to mind.) If we want to see where not doing so can lead us, we just need to look at Ireland and Britain.





TIPS THAT CAN HELP SENIORS QUIT SMOKING









